LunarSky Productions, Inc. – Authorization for Automatic Credit/Debit Card Withdrawal Form

LunarSky Productions, Inc. will make available to you, a billing statement at least ten (10) days before your credit/debit card account will be charged for your monthly provided service(s). The bill will indicate the amount to be charged, which may vary from month to month.

If your credit card company or bank refused to make a payment in accordance with this authorization and a monthly billing statement because you have exceeded your credit limit or there are insufficient funds in your account to cover the payment, your LunarSky Productions, Inc. account will be charged a dishonored payment fee of \$25.00 plus tax and you will remain responsible to LunarSky Productions, Inc. for the amount that was billed but not paid.

LunarSky Productions, Inc. will not be responsible for any actions or omissions that your credit card company or bank may commit or allow to occur in violation of your bank's legal or contractual obligations to you.

Questions about your LunarSky Productions, Inc. Services bill should be directed to LunarSky Productions, Inc., not the credit card company or bank.

This authorization will be processed by LunarSky Productions, Inc. as soon as possible. However, this may not occur in time for payment of your next billing statement. If your next billing statement does not indicate that an automatic payment will be taken from your bank account, you should pay that bill by check, credit card or money order.

LunarSky Productions, Inc. may terminate automated billing to your bank account at any time, upon at least ten (10) days advance written notice to you.
